Harlem RBI's after-school and summer programs serve 1,500 East Harlem and South Bronx boys and girls, ages 5-22, each year. Harlem RBI's approach to youth development and education addresses the barriers inner-city youth typically face by providing concrete opportunities to build the skills and confidence needed to break the cycle of poverty. All Harlem RBI participants play on a baseball or softball team, which serves as both a "hook" to attract youth participation and a tool to help youth develop as leaders, teammates and individuals. Harlem RBI's off-the-field activities consist of a series of age-appropriate, team-based after-school and summer programs that change over time as participants grow from year to year. Programs are free of charge and open to all participants regardless of athletic or academic ability. Once youth join Harlem RBI, they are a part of a safe, supportive and engaging environment where they can play, learn and grow until they graduate from high school and college.

Harlem RBI and its programs have been recognized nationally and locally by leading youth development organizations and other industry leaders. In 2014 Harlem RBI was a recipient of the Steve Patterson Award for Excellence in Sports Philanthropy, and in 2013, Harlem RBI received EmblemHealth's Commitment to Care Award. In 2012, Harlem RBI was named a Robin Hood Hero as well as a winner of the SEG Foundation Excellence in Action Award and the New York Community Trust-New York Magazine Nonprofit Excellence Award Silver Prize for Management Excellence. Harlem RBI's Board of Directors also received the Volunteer Consulting Group's Brooke W. Mahoney Award for Outstanding Board Leadership in 2010, and was named a finalist again in 2011.

Harlem RBI's participants avoid the perils that trap many inner-city youth while working toward high school graduation and college matriculation. Harlem RBI's
